1 Chairman's Welcome and Announcements and apologies for absence

Apologies were received and accepted from AE and AC.

#### 5 Police Report

5.1 The police reports for September and October were received as follows:

September – 3x crimes reported (1x common assault, 1x harassment, 1x theft from vehicle)

October - 7x crimes reported (1x common assault, 1x burglary, 1x harassment, 1x fraud, 1x road rage, 1x theft from vehicle, 1x theft of motor cycle).

- 6 Reports from County & District Councillors.
- 6.1 TA reported that he had met with David Allfrey from Norfolk County Council to push for a weight restriction through Felthorpe, on The Street. DA had advised that the decision would be made by the Highways Manager, who he would discuss it with. Councillors reiterated that the NNDR had not performed according to predictions and reduced the amount of traffic coming through the parish, and so the weight restriction was required.
- 6.2 Brands Lane residents asked for more information on how a potential closure of the road to through traffic would work. TA explained that access would be available for residents and farm vehicles, but that 70% of the residents in the affected area would have to agree to the closure in order for it to be agreed. It was agreed to add a discussion around this to the December agenda.

- 8.1 BB reported that 4400 vehicles a day had passed through the parish via Taverham Road over the past two weeks.
- 8.2 NCC had published four proposed routes for the western link, to complete the NNDR. Road-shows would be held to publicise these.
- 8.3 The roundabouts on the NNDR being modified due to a number of accidents,
